Job Information

C& O Forestry, Inc is looking to fill 26 Forestry Worker positions. Work site(s): Begin; Medford, Jackson County, OR 97501 @ \$19.55/hr. Provided daily transportation to and from the worksite. Continue into States of AZ, CA, CO, ID, NV, OR, UT, WA, WY. This is a temporary, full-time seasonal position from 12/18/2021 to 10/17/2022.

Duties: Raise/transport/sort seedlings. Plant: seedlings/trees. Trim trees or other vegetation; cut trees or logs. UNDER THE DIRECTION OF FIRE SUPPRESSION OFFICERS OR FORESTRY TECHNICIANS: fight forest fires or perform prescribed burning tasks, fire protection, and suppression via clearing/disposing of brush, thinning, piling, and digging line/constructing fire breaks & other related Forestry Worker activities as per SOC/OES 45-4011 (onetonline.org).

Requirements: Must be 18 due to travel. Must show proof of legal authority to work in the U.S. Drug/Alcohol/Tobacco free work zone. Must walk substantially (up to 15 miles/day), also stoop, bend while carrying a pack (up to 50lbs) thru rough terrain (non-trail). Must have 3 months Commercial Brushsaw/Chainsaw exp. No minimum education requirement. All applicants must be able, willing, qualified to perform work described and must be available for the entire period specified and work throughout all areas of intended employment.

Terms & Conditions of Employment: \$15.00/hr up to possible \$22.00/hr OT \$22.50/hr up to possible \$33.00/hr. Wage may vary. Based on Experience and/or location. The wage(s) offered equal(s) or exceed(s) the highest of the prevailing wage or the Federal, State, or local minimum wage. Bonuses may apply.
