Job Summary Live-In Full Time Nanny – 1 temporary, full-time position one-time occurrence job available from 12/23/2021 to 08/26/2024 in Morgantown, WV. Duties will be performed and the worker will reside, at the location of the employer Emily Gammoh in Morgantown, WV. Job Duties: Care for a child, perform all related child care duties in regards to the child and come up with early childhood activities to lead the transition stage. Plan and prepare meals/snacks and feed the child, including bottle-feeding. Change diapers and bathe the child and potty training. Supervise child's activities and monitor safety at all times. Craft activities for neurological development. Education and Experience: No educational requirement, but it requires 1 year of experience. Work days: Mon-Fri, hours 8:00 am- 4:00 p.m. This is a live-in position in Morgantown, WV 26508. Wage is \$10.20/hour for 40 hours per week and overtime, if any, is \$15.30/hour. Employer guarantees to offer work for the hours equal to at least 3/4 of the workdays in each 12- week period of the total employment period. A single workweek will be used to compute wages due. Worker will be paid once every two weeks on a Friday. All deductions from the worker's paycheck required by law will be made. As this is a live-in position, employer provided housing and utilities are provided at no cost to the worker. Three meals/day are also provided to the worker at no charge. Employer will provide workers at no charge or deposit all tools, supplies and equipment required to perform the job. The worker will be reimbursed in the first workweek for visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees). If the worker completes 50% of the work contract period the employer will reimburse the worker for transportation and subsistence.

Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Workers will be provided with daily transportation to and from the worksite at no cost in compliance with all applicable Federal, State and local laws and regulations. In addition, daily subsistence will be provided at a rate of \$13.17 per day during travel to a maximum of \$55.00 per day with receipts.
