We are a Drug Free Workplace. We do random testing, upon the employers reasonable suspicion of an employees drug use, and post-accident. Employer provided transportation from workshop to sites in Collier county. Pay: \$17.47/hr, OT at \$26.21/hr. Workers paid weekly. Optional housing available. If elected, the reasonable cost of housing will be deducted from pay. On-the-job training provided. Raises and/or bonuses may be offered to any worker in the specified occupation, at the company's sole discretion, based on individual factors including work performance, skill and tenure. Single workweek will be used to compute wages due. All deductions from the workers paycheck required by law will be made. If the worker completes 50% of the work contract period, the employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence provided at a rate of at least \$13.17/day during travel, without receipts, to a maximum of \$55.00/day with receipts.
