Set and align forms that hold concrete. Spread, level and smooth concrete using rakes, shovels or hand tools. Tear down concrete forms. Clean up construction site. No prior education required. Must have 3 months concrete finishing experience. Daily transportation to and from the worksite will be provided. \$23.64/hr.

Applicants may be offered higher than the advertised wage rate due to experience or merit. Approx. 40 hours/week, Mon-Fri, some weekends, 7am-6pm. Up to 10 hours of overtime may be available but is not guaranteed.

\$35.46/hr. for overtime. All deductions from the worker's paycheck will be made as required by law. The employer will use a single workweek as its standard for computing wages and pay bi-weekly by check. The employer will provide housing as an option to the employees. Employees who elect to live in the housing will have an additional \$175.00 deducted per bi-weekly paycheck for rent and utilities. Any advances will be deducted with the consent of the employee. In the first workweek, the cost of transportation (including meals and to the extent necessary, lodging) to the place of employment will be directly reimbursed to every worker. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer.
