Duties: Workers will carry set of planting bags with 500 to 1,000 tree seedlings to be planted using various planting techniques 1 seedling at a time, dig holes, plant using planting tools, pack seedling down to allow for optimal growth & other related Tree Planters activities as per SOC/OES 45-4011 (onetonline.org).

Requirements: Must be 18 due to travel. Must show proof of legal authority to work in the U.S. Drug/Alcohol/Tobacco free work zone. Must walk substantially (up to 15 miles/day), also stoop, bend while carrying a pack (up to 50lbs) thru rough terrain (non-trail). No minimum education requirement. On-the-job training available. All applicants must be able, willing, qualified to perform work described and must be available for the entire period specified and work throughout all areas of intended employment.

Terms & Conditions of Employment: \$8.80/hr up to possible \$22.25/hr OT \$13.20/hr up to possible \$33.38/hr. Wage may vary. Based on Experience and/or location. Optional housing available at no cost. Will reimburse the H-2B worker in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker (not including passport).
