Duties: Tree planting, grubbing/scalping, tubbing, hand tree pruning, spraying, thinning, hand release, fuel reduction hand piling, pile burning. No minimum education requirement. All applicants must be able, willing, qualified to perform work described and must be available for the entire period specified and work throughout all areas of intended employment.
