**Position Duties:** Server/Bartender/Cashier will be responsible for taking orders and serving food and beverages to patrons at tables; mixing and serving drinks to patrons; receive and disburse money, may use electronic scanners, cash registers, or related equipment. May process credit or debit card transactions and validate checks.

**Rate of Pay:** \$18.16/hour + DOE (The employer will pay or exceed the prevailing wage, as determined by the US Dept of Labor)  
**Hours per Week:** 40 (OT is possible, to be paid at \$27.24/hour + DOE).

Single workweek will be used to compute wages due. All deductions from the worker's paycheck required by law will be made. Workers will be paid every week by check.

The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved.

Daily subsistence will be provided at a rate of \$14.00 per day during travel to a maximum of \$59.00 per day with receipts.

The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period.

H-2B workers will be reimbursed in the first work week all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees).

The employer will provide workers at no charge all tools, supplies, and equipment required to perform the job.
