Daily subsistence provided at a rate of at least \$14.00/day during travel to a maximum of \$59.00/day with receipts. H2B Workers will be reimbursed in the first workweek for all visa, visa processing, border crossing and other related fees, including those mandated by the government (except passport fees).
