Duties include responsible for cleaning guestroom, hotels. Making beds, replenish linens, cleaning rooms, cleaning halls, setting out towels and toiletries daily. 8:30a-5:00p. \$13.00/hr, OT varies at \$19.50/hr. No minimum experience or education required. A single workweek will be used to compute wages due. All deductions from the worker's paycheck required by law will be made. Workers will be paid bi-weekly. Employer will pay for (or reimburse w/in 1 week) all visa/travel related fees & incidental expenses (except passport fees); We do not provide lodging but will assist workers to find lodging. Workers are responsible for paying for their own lodging including utilities. Employer does not provide workers daily board (food). Workers are responsible for obtaining and preparing their own food. - Clean rooms, hallways, lobbies, lounges, restrooms, corridors, elevators, stairways, locker rooms, and other work areas so that health standards are met.
- Clean rugs, carpets, upholstered furniture, and draperies, using vacuum cleaners and shampooers.
- Replenish supplies, such as drinking glasses, linens, writing supplies, and bathroom items.
