Job Description: North Country Wreath Company (Duluth, MN) needs 41 full-time temporary LABORERS from 10/10/2022 to 12/3/2022. Job is located at the Carlton County Fairgrounds in Barnum, MN.

Job duties include clamping bunches of live evergreen boughs on a wire frame to form a Christmas wreath or garland and moving raw or finished goods. No specific skills, certifications or education required. Previous experience preferred but not required. Must be able to move raw or finished goods up to 50lbs, stand for a minimum of 7 hrs/day and have the dexterity and strength to use hand tools required. On the job training and all tools, supplies and equipment required to perform the job will be provided at no charge.

Starting wage is \$13.35/hour. M-F, 6am-1:30pm, 35hrs/wk, possibly more. No benefits. Any overtime hours worked will be paid \$20.03/hour. Single workweek will be used in computing wages. Paid weekly. All deductions comply with federal, state and local requirements. No other deductions such as for the cost of board, lodging or other facilities will be made. Transportation (including meals and, to the extent necessary, lodging) to the place of employment will be provided, or its cost to workers reimbursed, if the

worker completes half the employment period. Return transportation will be provided if the worker completes the employment period or is dismissed early by the employer. Daily subsistence will be provided at \$14/day during travel to a maximum of \$59/day with receipts. Assistance to obtain board, lodging or other facilities will be offered by helping to find available housing. Visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker will be provided or reimbursed in the first workweek.
