Superior AJ Forestry is looking to fill 34 Forestry Worker positions. This is a temporary, full-time seasonal position from 12/15/2022 to 9/30/2023.

Begin/report to work: 2165 Lotus Ln Central Point, OR 97502 @ \$21.04/hr. Daily transportation provided between report to work address and additional worksites.

Worksites: States of AZ, CA, CO, MT, ND, NM, NV, OR, SD, UT, WA, WY.

Duties: Raise/transport/sort: tree seedlings, discarding substandard seedlings, according to standard charts or verbal instructions. Plant: seedlings/trees. Reduce competing vegetation: trim trees or other vegetation - cut trees/logs. UNDER THE DIRECTION OF FIRE SUPPRESSION OFFICERS OR FORESTRY TECHNICIANS: fight forest fires or perform prescribed burning tasks, fire protection, and suppression via clearing/disposing of brush, piling, and digging line/constructing fire breaks & other related Forestry Worker activities as per SOC/OES 45-4011 (onetonline.org).

Requirements: Must be 18 due to travel. Must show proof of legal authority to work in the U.S. Drug/Alcohol/Tobacco free work zone. Must walk substantially (up to 15 miles/day), also stoop, bend while carrying a pack (up to 80lbs) thru rough terrain (non-trail). No minimum education requirement. On-the-job training available. All applicants must be able, willing, qualified to perform work described and must be available for the entire period specified and work throughout all areas of intended employment.

Terms & Conditions of Employment: \$13.98/hr up to possible \$30.00/hr OT \$20.97/hr up to possible \$45.00/hr. Wage may vary. Based on Experience and/or location.
