This is a temp, fulltime position & we are looking to fill 11 job openings for employment from 10/1/2023 to 6/30/2024.**

Job Duties and Requirements include: Wash or otherwise clean agricultural & commercial trucks & equipment. Use water, cleaning agents, pressure washers, scrubbers, brushes, cloths and hoses. Cleaning valves, interior and exterior of hoses and pipes, hose trays, ladders, platform for hatches, on semi-trailer trucks, RVs and other vehicles. Involves bending, stooping, lifting and stretching on a frequent basis. Must be able to lift 50 lbs often, may involve lifting 75 lbs, work in extreme weather conditions. Work at heights up to 13'. May provide housing if available, housing is optional. \$300 per person/per month, tenant pays utilities separate (subject to change based on local market/inflation). Rent WILL NOT be deducted from pay. Possibility of performance based raise, bonus, overtime and Saturdays. 1 hr non paid lunch. Transportation provided to worksites from central location in Port Allen, LA.

Terms & Conditions of Employment: \$13.73 to \$15.00 per hour at least 40 hours per week. M-Sa 8:00

AM to 5:00 PM (schedule varies). Overtime is available as needed. Overtime rate is \$20.60 to \$30.90 per hour. Possibility of Performance based raise.

Transportation: Employer will provide advance transportation costs for most economical common carrier for workers, either foreign or domestic, to place of employment from place of recruitment and reimburse subsistence when worker completes 50% of the work period.

Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distance involved. Daily subsistence to be reimbursed at a minimum amount of \$15.46 per day during travel to a maximum of \$59.00 per 24 hour period (with receipts) of travel.

Three-fourths guarantee: The employer guarantees to offer work for hours equal to at least three fourths of the workdays in each 12-week period of the total employment period.

Tools, Equipment and Supplies: Employer will provide all tools and supplies, without charge or deposit, necessary to perform job duties.

Miscellaneous: Employer will use a single work week as its standard for computing wages due; pay is weekly, employer will make all deductions from worker's paycheck required by law and will not make any deductions which are not required by law. H-2B Workers whom paid visa, border and or other visa related fees, including those mandated by the government, will be reimbursed by employer in the first workweek.
