## Job Description

4 cooks openings at The Maine Diner in Wells ME. Temporary & Full-Time (40 hours) April 1, 2024 to November 1, 2024. Cook standard diner menu items for breakfast, lunch and dinner including seafood dishes. Prepare food to correct standards. Keep food prep areas sanitary and clean. No experience required; will train. The employer will use a single workweek as its standard for computing wages due. Workers will be paid biweekly. The employer intends to assist workers to secure housing. The employer will make all deductions from the worker's paycheck required by law. The worker will be provided with pre-paid non-refundable transportation from the place from which the worker has come to work for the employer, whether in the U.S. or abroad, to the place of employment, including daily subsistence rates at a cost of \$15.46 per day during travel to a maximum of \$59.00 per day with receipts. The employer will provide or pay for the worker's cost of return transportation and said daily subsistence from the place of employment to the place from which the worker, disregarding intervening employment, departed to work for the employer, if the worker completes the certified period of employment or is dismissed from employment for any reason by the employer before the end of the period. The employer will reimburse the worker by company check in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the worker. The employer will provide to the worker, without charge or deposit charge, all tools, supplies, and equipment required to perform the duties assigned. Guaranteed work offered for a total number of work hours equal to at least three-fourths of the workdays of each 12-week period, if the period of employment covered by the job order is 120 or more days, or each 6-week period, if the period of employment covered by the job order is less than 120 days.
